These Terms & Conditions govern your use of services provided by **Bridge Nepal Treks and Travels** ("we," "our," or "the Company"). By booking or participating in any trekking, tour, or travel-related service with us, you acknowledge that you have read, understood, and agreed to these terms.

1. Definitions

- **"Client" / "You"**: Any individual or group booking or participating in services provided by the Company.
- **"Services"**: Trekking, guided tours, travel assistance, and any related activities organized by the Company.
- **"Guide"**: A representative of the Company assigned to lead or assist in treks and tours.
- **"Booking"**: Confirmation of participation in any trekking or travel service offered by the Company.

2. Scope

These Terms apply to all trekking, adventure, and travel services arranged by **Bridge Nepal Treks and Travels**. By engaging with our services, you agree to abide by all rules, safety guidelines, and instructions provided by our guides and staff.

3. Booking & Confirmation

- Bookings can be made through official communication channels provided by the Company.
- All bookings are subject to availability and confirmation by the Company.
- Any special requests (e.g., dietary preferences, health considerations) must be communicated at the time of booking.

4. Health & Fitness Requirements

- Trekking and adventure activities may require a reasonable level of physical fitness.
- You are responsible for assessing your own health and ensuring you are medically fit to participate.
- Please inform the Company in advance about any medical conditions, allergies, or physical limitations.

5. Travel Documents & Insurance

- Clients are responsible for carrying valid identification, permits, and other required documents.
- We strongly recommend that clients arrange **personal travel insurance**, covering medical emergencies, accidents, and evacuation, before starting any trek or adventure activity.

6. Itinerary Changes & Flexibility

- Trekking itineraries may change due to weather, road conditions, or other unforeseen circumstances.
- The Company reserves the right to make necessary adjustments to ensure the safety and comfort of clients.
- No refunds or compensation will be provided for itinerary changes caused by circumstances beyond our control (e.g., natural disasters, political unrest).

7. Code of Conduct

- Clients are expected to respect local customs, culture, and the natural environment.
- Follow all instructions given by guides for safety purposes.
- Any form of misconduct, including endangerment of others, may result in removal from the trek or tour without refund.

8. Limitation of Liability

- Trekking and adventure travel involve inherent risks, including accidents, injuries, illness, or unforeseen natural events.
- The Company and its staff will take reasonable precautions but **are not liable for personal injuries, losses, or damages** occurring during activities unless caused by proven negligence.
- Clients participate entirely at their own risk.

9. Cancellation & Refunds

- Since there is **no online payment system**, cancellations should be communicated directly through the Company's official contact channels.
- Any refunds or adjustments will be handled case by case, as per mutual agreement.

10. Photography & Marketing

- The Company may use photos or videos taken during treks for promotional purposes unless you explicitly request otherwise in writing.

11. Governing Law

- These Terms are governed by the laws of **Nepal**.
- Any disputes shall be resolved in the competent courts of Nepal.
